As a condition for obtaining a permit to operate in Lakewood, the lot owner(s) and operator(s) listed on this application agree to observe posted speed limits and operate the all-terrain or utility vehicles, motor bikes, and/or golf carts listed on this application in a safe manner in accordance with West Virginia state law, applicable ordinances, and Lakewood policies, including the following:

- ATVs, UTVs, motor bikes, and golf carts operating on Lakewood streets and on designated Lakewood Enterprises property and off-road trails must display a valid Lakewood numbered permit on the rear of the vehicle.
- 2. Drivers must operate motorized vehicles at low rpm on Lakewood streets (i.e., no loud revving of engines on streets) and observe the posted speed limit of 20 mph.
- Unless there is a physical obstacle, drivers must always operate motorized vehicles in single file on the right side of the street. Absolutely NO racing or tandem riding is ever permitted on Lakewood streets.
- 4. Drivers shall be respectful of neighbors and property. Drivers shall slow and yield the right of way to pedestrians, bicyclists, and pets with which they must share Lakewood streets.

IMPORTANT NOTICE

All use of ATVs, UTVs, and motor bikes in Lakewood and on designated Lakewood Enterprises fields, roads, and off-road trails is at the risk of the User and Lot owner. Vehicle riding in hayfields is restricted to the outer edges of the fields. Riding privileges on Lakewood properties are NOT extended to non-residents of Lakewood. The unauthorized use of ATVs, UTVs, motor bikes, and golf carts in Lakewood will be considered trespassing and subject to prosecution. Unsafe operation or violations of this agreement are subject to fines and sanctions up to and including revocation of riding privileges in Lakewood.

By signing, I agree to operate an ATV, UTV, motor bike or golf cart in Lakewood in a safe manner and in compliance with the laws, rules, policies, and safety guidelines referenced in this application:
